During this program, we will discuss how proper documentation of wounds is essential for minimizing the risk of litigation. We will also go over techniques for documentation to allow you to meet regulatory and reimbursement requirements.
CEU Skin Care	Incontinence Associated Dermatitis	31:20	This module will empower you to define and understand incontinence-associated dermatitis (IAD). Once completed, you should be able to identify assessment and intervention tools that may assist healthcare professionals in identifying and managing IAD. We will review evidence-based protocols of care for prevention and management of IAD and learn to differentiate IAD from pressure ulcers.
CEU Skin Care	Preventative Skin Care	29:15	Upon completion, this module should help you to describe the anatomy and physiology of healthy and at-risk skin, and identify the elements of a comprehensive skin assessment. You will also learn to describe evidence-based protocols of care for maintaining healthy skin and review the definition, causes, prevention and management of skin tears.
CEU Wound Care	Wound Assessment and Documentation	43:28	During this module, you will learn to identify how wounds are classified according to depth and etiology and list at least three characteristics to document as part of a wound assessment. This module will also help you identify resources to assist documenting wounds and learn to list signs and symptoms of wound infection.
CEU Wound Care	Pressure Ulcer Prevention and Management	44:08	This module will train you to describe the etiology of a pressure ulcer and describe the appropriate product categories that can be used based on wound characterization. It will also review evidence-based product categories that can be used based on wound characteristics.

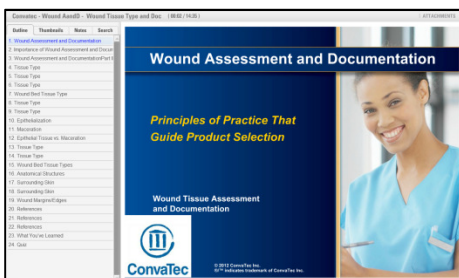

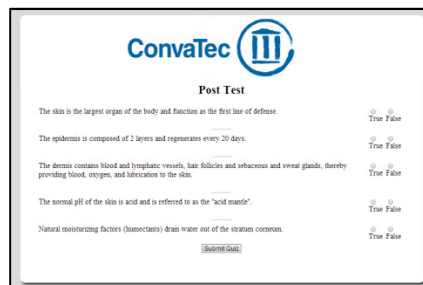
